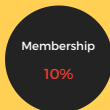




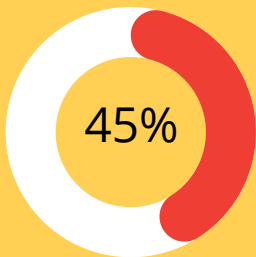

Virtual attendance: 20,000

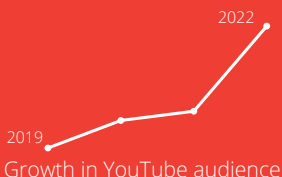

MFA ALSO HOSTS VIRTUAL EXHIBITIONS FEATURING INTERNATIONAL ARTISTS.

ARTISTS FROM 47 STATES, DC, AND 20 OTHER COUNTRIES HAVE ENTERED MFA EXHIBITIONS. ARTISTS LIVING OUTSIDE OF MARYLAND REPRESENT 45% OF ALL ENTERING ARTISTS.
